

# GUEST - DRESS CODE POLICY & LIGTENING POLICY

At Sugar Mill Country Club, we strive to create an environment that is relaxing, yet worthy of our reputation as a premier private and family Club facility. With golf as the central offering of our Club, Members and guests are always expected to observe the rules of golf and to practice proper golf course etiquette.

The purpose of our Dress Code Policy is to provide members and their guests with guidelines as to appropriate dress when at Sugar Mill and utilizing the various venues of the facility. Members are asked to use good judgment in their attire decisions when at the Club. If you are unsure of the appropriate dress for an event, please contact the managing Director.

# Clubhouse Dress Code

#### MEN'S DRESS

**Sunrise Grille/Snack Bar** – This venue provides for the most flexible and relaxed standards of the Dress Code Policy. Unacceptable attire is as follows: tank tops, sleeveless T-shirts, and cut-offs. Appropriate golf, tennis, and workout clothing are acceptable. Blue jeans and denim are acceptable. If coming from the pool area proper cover-ups are required. Footwear such as flip-flops and sneakers are acceptable. Headwear is permitted.

**Sunset Lounge** – This venue calls for slacks, golf shorts, collared shirts, mock turtle or turtlenecks and appropriate footwear. Shirts must be tucked in unless designed for outside wear. Sweaters, jackets, sport coats, golf outerwear and rainwear are acceptable.

Tennis wear is acceptable. Headwear may not be worn in the Sunset Lounge. Denim shirts, T-shirts and tank tops are not permitted. Denim shorts and cut-offs are not permitted. Presentable denim and blue jeans are permitted if it is not torn, ripped, or frayed. If, however, the Sunset Lounge is full, and overflow occurs into the Main Dining Room denim will not be permitted in the Main Dining Room.

**Main Dining Room & Ballroom** – These venues call for "Country Club Appropriate" dressing (as defined below) including slacks, collared shirts, mock turtle or turtlenecks. Shirts must be tucked in unless designed for outside wear. Sport coats are preferred but not required. Headwear is never allowed. Denim of any color or blue jeans or shorts are generally not acceptable for the Main Dining Room or Ballroom. There may be exceptions to this rule; a good example is when events held in the Sunset Lounge require overflow into the Main Dining Room. The key to utilizing the Main Dining Room or Ballroom is to dress up and not down.

WOMEN'S DRESS

**Sunrise Grille/Snack Bar** – This venue provides for the most flexible and relaxed standards of the Dress Code Policy. Unacceptable attire includes the following: tank tops, tube tops and cut-offs. Appropriate golf, tennis and workout wear is acceptable. Blue jeans and denim are acceptable. If coming from the pool area proper cover-ups are required. Footwear such as flip-flops and sneakers are acceptable. Headwear is permitted.

**Sunset Lounge** – This venue calls for slacks, golf shorts, capris, skirts, knit or woven tops and appropriate footwear. Golf outerwear and rainwear are acceptable. Tennis wear is acceptable. Headwear is acceptable for ladies. Denim shorts and cut-offs are not permitted. Presentable denim of any color and blue jeans are permitted as long as it is not torn, ripped or frayed. If, however, the Sunset Lounge is full and overflow occurs into the Main Dining room denim will be permitted in the Main Dining Room.

**Main Dining Room & Ballroom** – These venues call for "Country Club Appropriate" attire (as defined below) including: dresses, slacks, skirts, knit or woven tops and appropriate footwear. Denim or jeans are generally not permitted, but again, there will be exceptions to this rule. Headwear is not permitted. The key to utilizing the Main Dining Room or Ballroom is to dress up and not down.

## Club Sponsored Events:

Appropriate dress is always required for club sponsored events, like that required in the Main Dining Room and Ballroom unless specified otherwise. Certain events may be formal. Boys 15 and under will be allowed to wear a collared shirt when jackets are required. Attire for such events will be specified by Management.

#### "COUNTRY CLUB APPROPRIATE" - MEN

For men this includes the following: Slacks, collared shirts, mock turtle or turtlenecks, sweaters, sport coats/blazers preferred and appropriate footwear. Shirts must be tucked in unless designed for outside wear such as Hawaiian style/Tommy Bahama type shirts. Sport coats or blazers are preferred but required for only certain occasions as identified by Management.

#### "COUNTRY CLUB APPROPRIATE" - LADIES

For ladies this includes the following: Dresses, slacks, skirts, appropriate knit or woven tops and appropriate footwear.

The Food & Beverage Management and staff reserve the right to make final decisions regarding compliance with the dress code policy.

## GOLF COURSE & PRACTICE FACILITIES

#### MEN'S DRESS POLICY:

Collared shirts, mock turtle or turtlenecks or polo-style tops with collars and sleeves; this includes "razor" collard style golf shirts; slacks or Bermuda-style shorts represent appropriate attire. Tennis wear, tank tops, tee shirts, sweatshirts, jeans, jean shorts, cutoffs, short shorts or sweatpants are not permitted. All shirts and polo-style tops must be tucked in at the waist. Golf shoes without metal spikes, spikeless golf shoes and sneakers are appropriate footwear. If the weather warrants, jackets, sweaters, and sweatshirts may be worn. They may have a small logo or insignia but no loud or offensive graphics.

WOMEN'S DRESS POLICY:

Blouses with or without sleeves, polo-style tops with collars (including stand or mandarin-type collars, jewel necklines, boat necklines and small vee necklines), skirts, skorts, capris, slacks and mid-length shorts are appropriate attire. Halter tops, tank tops, tee shirts, tube tops, tennis attire, jeans or denim, athletic shorts, cutoffs or short shorts are not permitted. Golf shoes without metal spikes, spikeless golf shoes, and sneakers are appropriate footwear. If the weather warrants, jackets, sweaters, and sweatshirts may be worn. They may have a small logo or insignia but no loud or offensive graphics. The Golf Shop Management and staff reserve the right to make final decisions regarding compliance with this dress code policy.

### TENNIS CENTER

#### PLAYER'S DRESS POLICY:

Appropriate tennis attire is required at all times on the courts and the area adjacent to the courts. Clay court tennis shoes are required. Rough soles, sneakers or walking shoes are not permitted on Har-Tru courts. Tennis related shirts and shorts must be worn. Men may not wear tank tops; women may not wear halter-tops. The Tennis Pro and staff reserve the right to make final decisions regarding compliance with this dress code policy.

### PICKLEBALL CENTER

#### PLAYER'S DRESS POLICY:

Appropriate attire is required at all times on the courts and the area adjacent to the courts. Proper footwear is required for member safety and court preservation. No flipflops, open toed or sling back footwear. Pickleball related shirts and shorts must be worn. Men may not wear tank tops; women may not wear halter-tops. The Tennis Pro and staff reserve the right to make final decisions regarding compliance with this dress code policy.

# LIGHTNING SAFETY POLICY

Ultimately our members and guests are the final judges of hazardous weather conditions before any alerts are sounded. They should seek protection at any time they believe there is danger from lightning. To assist in this determination, the Club has installed the Thor Guard Lightning Protection System. The System will automatically sound an alarm at the Clubhouse and at five remote locations on the golf course when lightning is in the area.

For anyone hearing or being informed of the RED ALERT: (one long sustained blast), it is mandatory that he or she leave the golf course, practice areas, tennis courts, swimming pool or any exposed area and seek shelter immediately in the Administration Building, Golf Shop, Clubhouse or at home.
